Disclaimer

2. The OFA and its directors, officers, committee members, members, employees, volunteers, participants, agents and representatives (collectively the "OFA") are not responsible for any injury, personal injury, damage, property damage, expense, loss of income or loss of any kind suffered by a Participant during, or as a result of, any program, activity or event, caused in any manner whatsoever including, but not limited to, the negligence of the OFA.

I have read and agree to be bound by paragraphs 1 and 2

Description of Risks

3. I am participating voluntarily in the sport of Floorball and the activities, events and programs of the OFA. In consideration of my participation in the sport of Floorball and the programs, activities and events of the OFA, I hereby acknowledge that I am aware of the risks, dangers and hazards associated with or related to the sport of Floorball and any such programs, activities and events of the OFA including injuries which can be **severe and even fatal**. The risks, dangers and hazards include, but are not limited to, injuries from:

- a) Exerting and stretching various muscle groups, strenuous cardiovascular workouts and heatstroke;
- b) Vigorous physical exertion, rapid movements and quick turns and stops;
- c) Falling, tumbling or hitting other participants;
- d) Falling to the ground or floor due to uneven, slippery or irregular surfaces;
- e) Contact, colliding or being struck by the Floorball, net, poles, other individuals, equipment, walls, stands, or benches;
- f) Failing to play within one's abilities and within designated areas;
- g) Failure to properly use any piece of equipment or from the mechanical failure of any piece of equipment;
- h) Animal attacks; including but not limited to, dogs;
- i) Extreme weather conditions which may result in heatstroke, sunstroke or lightning strikes;
- j) Spinal cord injuries which may render me permanently paralyzed; or
- k) Travel to and from competitive events and associated non-competitive events which are an integral part of the OFA's activities.

4. Furthermore, I am aware:

- a) That injuries sustained can be severe;
- b) That I may experience anxiety while challenging myself during the activities, events and programs;
- c) That my risk of injury is reduced if I follow all rules established for participation; and
- d) That my risk of injury increases as I become fatigued.
